4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to Doctor or Hospital.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

PPE for First Aiders: Wear overalls, safety glasses and impervious gloves. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact. 6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

LARGE SPILLS

Clear area of all unprotected personnel. Prevent further leakage or spillage if safe to do so. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. 7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

Reactivity: No reactivity hazards are known for the material.

Chemical stability: This material is thermally stable when stored and used as directed.

Hazardous reactions: Reacts with zinc to form explosive hydrogen gas. Catalyses exothermic polymerisation of vinyl ether. Explodes at room temperature when added to furan-2-percarboxylic acid. Exothermic reaction when added to water.

Conditions to avoid: Elevated temperatures and sources of ignition.

Incompatible Materials: Boric acid, calcium oxide and bromine trifluoride.

Hazardous decomposition products: Oxides of carbon and nitrogen, smoke and other toxic fumes.
