### 4. FIRST AID MEASURES

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## 10. STABILITY AND REACTIVITY

**Chemical stability:** This material is thermally stable when stored and used as directed.

**Conditions to avoid:** Elevated temperatures and sources of ignition.

**Incompatible materials:** Strong oxidisers. Avoid contact with concentrated sulphuric and nitric acids.

**Hazardous decomposition products:** None known.

**Hazardous reactions:** Sodium chloride reacts violently with bromine, tri-fluoride and lithium. Under wet conditions, sodium chloride will corrode many common metals, particularly iron, aluminium, and zinc. Reacts with strong sulphuric acid or nitric acid liberating hydrogen chloride gas.

## 11. TOXICOLOGICAL INFORMATION
